SECTION B - REQUIREMENTS FOR DEPOSIT

- A URS Traditional IRA or URS Roth IRA must be opened before any deposit will be accepted.
- To open a URS IRA, log in to your account at urs.org or complete a URS *IRA Enrollment Contract (DTEN-1)*.
- Contributions to a Roth or traditional IRA may be subject to income limits based on your modified adjusted gross income. Please see *IRS Publication 590* or the *URS Roth and Traditional IRAs Guidebook* for details.
- For traditional IRAs, you must be under age 70 1/2 at the end of the year to be eligible to contribute.
- Contributions to an IRA can be made from January 1st of the current year until the tax filing deadline (generally April 15th) of the following year.
- IRA deposits will be invested according to your *investment of future contributions* on file with URS.
- For detailed information regarding the rules and regulations of traditional and Roth IRAs please see *IRS Publication 590*.
