#### **PEHP Rate Renewals**

Mr. Chet Loftis reviewed the Jordan School District, Salt Lake City School District, and Utah School Board Association (USBA) renewals that will be effective September 1, 2020.

**ACTION:** Mr. David Damschen moved, seconded by Mr. Bill Wallace, to ratify the following PEHP Renewals, effective September 1, 2020:

- Salt Lake City School District Medical/Rx 0.0% rate hold
- USBA Medical/Rx -3.0% decrease

## **Employee Compensation Package**

Mr. Dan Andersen reported that URS is in a soft hiring freeze. URS recommends following the state with a 0% COLA and 0% Merit for the 2020-2021 fiscal year for URS employee compensation. The salary structure will be adjusted so the salary grades do not get too far behind the market curve. Discussion followed.

**ACTION:** Ms. Laura Houston moved, seconded by Mr. Bill Wallace, to approve the 2020-2021 Employee Compensation Package of 0% COLA and 0% Merit. The motion passed unanimously, 7-0.

## **GRS Actuarial Valuation and Experience Study**

Mr. Danny White reviewed the Actuarial Valuation Report as of January 1, 2020, and the Actuarial Experience Study as of December 31, 2019, including the following topics:

- Changes Since Prior Valuation
- Membership Experience
- Asset Experience
- 2020 Experience Investigation
- Funded Status
- Contribution Rates
- Other Items

The valuation performed as of January 1, 2020, does not reflect possible impact due to the COVID-19 pandemic. The valuation reflects recommended assumption changes from the experience study performed this year. The analysis of the investment return assumption is delayed to next year.

**ACTION:** Mr. Richard Ellis moved, seconded by Mr. Bill Wallace, to accept the actuarial assumptions as contained in the Utah Retirement Systems Actuarial Valuation Report as of January 1, 2020. The motion passed unanimously, 7-0.

## **Approval of FY 2021-2022 Preliminary Contribution Rates**

**ACTION:** Mr. David Damschen moved, seconded by Mr. Roger Donohoe, to approve the proposed preliminary contribution rates for the 2021-2022 fiscal year as contained in Utah Retirement Systems Actuarial Valuation Report as of January 1, 2020, and found on pages 71-73 of the Board Book, subject to legislation in the 2021 General Session. The motion passed unanimously, 7-0.
