

# Launch Timeline

- Data Conversion Began March 20<sup>th</sup>
- Officially in Blackout Period – Until 3/30
  - No payroll files or payroll changes
  - Employer Portal not available
  - myURS limited access – only visible:
    - Statements
    - Tax forms
    - Direct deposit notices
- Final Preparation Activities in Progress

# Getting Ready for Launch

- Review Training Materials and Communication from URS
- Allow Extra Time
- Identify Organization Contacts in Preparation for Day 1
- Keep Multiple Payrolls Separate
  - Do not consolidate into one file
  - Each payroll schedule reported on separate payroll file
  - Website wizards – report schedules separately




# What You Can Expect After Launch

- Go-Live: Monday, March 30<sup>th</sup>
  - Focused Web Administrator Support
  - Web Administrators receive registration email and establish user credentials
- Dedicated Support: March 31<sup>st</sup> – April 17<sup>th</sup>
  - Allows URS to assist more efficiently
  - Contact URS on allocated days:
    - Public Education: March 31, April 7, April 14
    - Higher Education, State of Utah, Quasi-State and Independent Agencies: April 1, April 8, April 15
    - Local government (cities, counties, towns, etc.): April 2, April 9, April 16
    - Employers Using Employer Portal Payroll Wizard: April 3, April 6, April 10, April 13, April 17
- Amnesty Period In Effect
  - Payroll files due March 7<sup>th</sup> – 29<sup>th</sup> and the first few weeks of April
  - Wait one hour before paying invoice after submittal to allow for adjustment
