### Welcome

Chair Marty Peterson called the meeting to order at 12:03 p.m. and welcomed Council members, staff, and guests.

# **Approval of Minutes**

Chair Marty Peterson asked for approval of the January 8, 2024, Membership Council Meeting minutes.

## **Report from Member Organizations**

Chair Marty Peterson asked Council members and guests to provide a report from their organizations. He stated today was the Annual Fire Caucus Luncheon where firefighters across the state meet with their legislators. The Professional Firefighters of Utah are still opposed to changes in the law that would make it hard for employees to pay union or association dues through payroll deductions. They are in support of retirement legislation. He also discussed a bill that proposes to have CO2 detectors in every building.

Ms. Heather Anderson reported the Utah Association of Special Service Districts are following around 200 bills. She stated that her members are comfortable with URS bills and thanked URS for the education they provide.

Mr. Rodney Hurd reported on a bill that requires having safety officers in every school, but the issues are finding well trained safety officers and funding. They are following H.B. 285 closely.

Ms. Anna Lewin stated that every Friday UEA has the option to attend Educator Day on the Hill. They are closely watching H.B. 285 and other bills that affect education.

Mr. Brandon Wolf stated they are watching H.B. 285 closely and are hopeful it will not pass.

Mr. Jason Putman said they too are closely watching H.B. 285 and H.B. 251.

There were no other legislative reports from the Council Members.
