## **Call to Order and Approval of Minutes**

President Bill Wallace called the meeting to order at 3:00 p.m. and welcomed Board members and staff.

#### **Legislative Update**

Mr. Dee Larsen distributed and reviewed document, "2017 General Session: Summary of Selected URS-related Bills" that shows the public legislation that may directly or indirectly affect URS systems and plans, health insurance, or retirement. He also distributed and reviewed a list entitled, Five Things to Remember in Dealing with the Utah Legislature. He reviewed some of the recent meetings with URS and legislators, including legislative leaders and the new committee chairs, to build relationships, provide background information, discuss retirement contribution rates and PEHP renewal rates, and to explain the Board's action and impacts from decreasing the assumed rate of investment return.
